## Draft Meeting Notes

### I. Call to Order and Introductions

The meeting was called to order at 12:40p.m. with Co-chair Bloom and Co-chair O'Leary present.

Staff indicated that there seems to be no issue with reauthorization of the McKinney-Vento Act. That most of the attention of the federal legislators is on the Stimulus Package. As well, staff was still waiting to learn what cities might apply for under the Stimulus Package.

This matter was referred to a small subcommittee to update the information and develop a final document. The subcommittee includes staff from Santa Monica, Culver City, West Hollywood and LA County Supervisor Yaroslavsky's office.

### IV. Report Back:

#### A. Debrief on LAHSA Homeless Count 2009

#### B. Request of Chair Bloom as to the status of the League's Committee on Housing. (Teresa Acosta, Regional Public Affairs Manager)

Rebecca Isaacs, executive director of Los Angeles Homeless Services Authority (LAHSA), reported that the LAHSA Homeless Count 2009 went very well. She indicated that the count was over 3 nights with 54 deployment centers which represented some 4500 volunteer nights. There were 16 opt in cities which is the most ever. With more cities opting into the count representing increased number of zip codes (about 50% more zip codes), there is a more accurate count with less need for extrapolation.

Ms. Isaacs stated further that now LAHSA is moving into the Part 2 (the Street Count being Part 1, of analyzing homelessness in the County), which is a very detailed demographic survey of the homeless population. Individuals within the homeless population will be selected to complete the survey. Therefore, Ms. Isaacs stressed the need for volunteers to administer the survey.

The efforts of the Westside Cities included:

- Most of the Westside Cities opted into the actual count;
- Beverly Hills was a deployment center with over 100 volunteers;
- Santa Monica conducted its own count over two nights with some 50 volunteers and over 100 have registered to attend a forum to report the count findings;
- Culver City was an opt in city, with the Culver City Senior as deployment site for both the Culver City count and Los Angeles (Venice area) count and over 100 volunteers, Culver City will report its count findings from all 4-9 census tracts to its Council;
- West Hollywood was an opt in city, with deployment centers and local volunteers, on count night, and on the next night conducted a Vulnerable Index count; and
- Los Angeles is putting its agenda together to release the count data and compliment LAHSA on its grass roots work.

Finally, a more accurate count will inform relative to the success of policies and efforts of many to reduce homelessness.

## **V. Discussion, WSCCOG Annual Issues Conference 2009**

Following lengthy discussion, staff concurred:

1. the focus of the Issues Conference 2009 should be Best Practices recognizing that the goal of ending homeless is to get people into housing;
2. could include a discussion of housing options for the homeless;
3. could include a session on *People Do Recover from Homeless* (some real cases where best practice have lead to good results); and
4. the Issues Conference 2009 should end with outcomes that the COG could take ownership of and move forward on.

There was also a lengthy discussion as to the target audience. It was agreed that the Conference would be an opportunity to elevate the issue to a more public discussion. It was discussed that target audience could include, large homeowner associations, business community and business community supporters such as BIDs, the faith based community, residents and other service organizations that have shown leadership in this area.

The discussion ended with the need for one city to take the lead on putting the Conference together, as has been done with the past conferences, and expression by staff that given the current budget constraints some cities are talking about, is there an alternative to a separate conference that should be considered, for example, joint partnering with another organization on an event. Given that there was unanimous support by the COG Board for the conference, this concern was referred to the Liaison/Technical Committee and the City Manager in particular for discussion.
