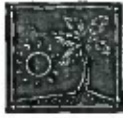

⁴ Audit firm Mayer Hoffman McCann has increased their audit fee by \$1,000 due to increase in audit standards

⁵ WSCCOG's share of contract enhancement: \$1350 for travel expenses + \$1832 salary augmentation = \$3182
